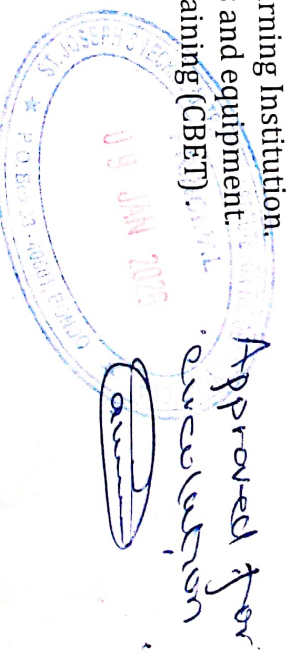

DUTIES AND RESPONSIBILITIES

- Provide technical support during practical training.
- Operate the conventional lathe machine, conventional milling machine and surface grinding machine.
- Operate CNC lathe machine.
- Operate CNC milling machine.
- Provide support in installation, operation, servicing and maintenance of mechanical equipment.
- Provide support in area of specialty by repairing and maintaining institution's mechanical work.
- Maintaining workshop inventories by receiving, issuing tools and materials in the workshop and ensure sufficient materials are in the workshop.

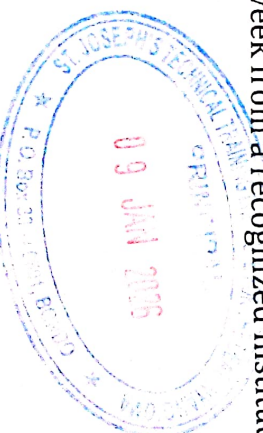
